- SMART RECOVERY BRIEF BACKGROUND Founded in 1994, SMART Recovery is an international non-profit organization which provides assistance to individuals seeking abstinence from addictive behaviors. The approach used is secular (non-religious) and scientifically based using non-confrontational motivational, behavioral and cognitive methods. Meeting participants learn recovery methods derived from evidence-based addiction treatments using a 4-point program: Building and Maintaining Motivation/Coping with Urges/Managing Thoughts, Feelings and Behaviors/Living a Balanced Life. SMART Recovery is the largest addiction recovery organization that does not use the "12-Step" approach used in Alcoholics Anonymous and Narcotics Anonymous. There are over 1500 weekly groups mostly in the United States, Canada, Australia and the United Kingdom. SMART Recovery is recognized as an effective treatment for addiction by the American Academy of Family Physicians, National Institute on Drug Abuse (NIDA), National Institute on Alcoholic Abuse and Alcoholism (NIAAA), the National Institutes of Health (NIH) all of which are components of the US Department of Health and Human Services.
- **ABOUT MONEY** SMART Recovery is free, but donations are accepted to pay for literature and refreshments. Leaders and hosts of meetings receive no money. It is all volunteer.
- ABOUT ME I am a volunteer host of SMART Recovery, working under Monica Forbes, a certified Facilitator for SMART Recovery. Monica is also the director of the PEER Wellness Center in Boise. I am retired and have a passion for helping alcoholics and addicts on their journey to recovery. I am currently planning on completing a 35 hour course to become a registered facilitator for SMART. - Office of Drug Policy Update, Community Coalitions of Idaho-September 2017
  - Marijuana, Epidiolex: GW pharmaceuticals now called Greenwich Biosciences in the U.S. has begun the FDA submission process Epidiolex has Fast Track designation in the treatment of Dravet Syndrome and GB will be able to submitting research modules as a "rolling" process as the modules are completed. GB expects to submit the final module in October. Completed. If FDA gives the drug Priority Review designation, the review cycle will be 8 months. DEA has up to 90 days to reschedule. If all goes smoothly, we expect the product to be available next year. This means that cannabidiol oil will be available in a consistent, quality controlled formulation that physicians will know how to dose for patients, as well as side effects to discuss with patients. In Idaho, our Expanded Access Program screened 40 pediatric patients. 39 patients received Epidiolex, and there was 1 screen failure. 3 patients have left the study due to inconvenience (i.e. the logistics with participating in the study were more burdensome than the benefit seen to patients enrolled in the trial).
  - Anticipated 2018 Session Legislation, CBD Bill: A representative from Stanley will be bringing a CBD access bill in the first two weeks of the session:
    - The bill is expected to bring the following provisions below, however, this may change prior to the session. Patients desiring to obtain CBD will be eligible to apply for a card and given legal access to CBD from outside the state
      - ODP Concern: Next year we will see a provision that allows for the cultivation and sale of the product in our state
    - A card will be issued annually to individuals upon recommendation from a physician
      - ODP Concern: Lack of specificity around which types of medical providers (e.g. neurologist) can issue a recommendation.
      - ODP Concern: Prescriptions typically have a set number of days for script renewal
    - No lab certification required (product must be >0.3% THC)

- ODP concern: ISP lab cannot quantify, which will incur state costs for the program to purchase lab testing equipment
- No quantity limits on how much product a patient can possess
- No provision to exclude those with a drug trafficking felony to apply for a card
- Unknown at this time: Form that the CBD may be obtained (e.g. oil, oral suspension, topical cream/gel, capsules, edible products)

- Medical marijuana bill (outside of CBD)
- Opioids, Opioid Strategic Plan: In April, ODP convened a multi-sector Opioid Misuse and Overdose Strategic Planning Retreat. This has resulted in a 5-year statewide strategic plan.
- Retail Pharmacy Drop Boxes: ODP is the recipient of grant funding intended to provide for startup costs and one year of reverse distribution for medication disposal programs in retail pharmacies. If you, or your coalition members, have contacts with a local retail pharmacy, please encourage them to apply for a mini-grant https://prevention.odp.idaho.gov/grant-opportunities/
- Over 2,780 community members reached through the coalitions prevention strategies since our meeting in Sept.
  - Treasure Valley Youth Safety Summit: 130 youth attendees selected from area schools.
     MADC presented and setup the Natural High Booth.
  - Recovery Day Breakfast: 12<sup>th</sup> Annual Recovery Day Breakfast had 50 attendees. The speaker, Ashley Marie spoke about her path to recovery.
  - Public Safety Day: over 252 conversations with families about prevention.
  - notMYkid presentations have not successfully attracted parents despite support from school teachers and administration. We will re-assess when and how to share this information. Red Ribbon Week included prevention presentations in Life Skills classes and assemblies held with speakers Natalie Marti & Monte Stiles. These events alone reached over 1,584 students.
  - o Trunk-or-Treat: MADC had the Natural High booth set up and gave away over 718
