	<ul> <li>Marijuana edibles: the impact of marijuana legalization is making its way over the boarders and into our schools. A student was caught selling marijuana laced cookies. Two weeks ago a traditional looking lollipop was found in one of the high schools. It was in its original packaging which showed it was a THC infused sucker. The largest cause of overdoses in CO has been from marijuana edibles. Serving size and delayed onset of psychoactive affects contributes to overdoses.</li> <li>Revised Law, Minor in Consumption: First offence is an infraction with \$487.50 fine. Second or subsequent offence is a misdemeanor so the offender would have to go to court. 	<ul> <li>Denver Drug Recognition Expert (DRE) Training: Field study for our Officers within Denver CO. Officers learned about what happened in CO once recreation marijuana became legal.</li> <li>\$7 million spent on the pro-movement for the passing of legal recreation marijuana. The verbage within the bill has caused many issues for the State: example, clause says "cannot use or be under the influence in the public setting." However nowhere in the state code does it define what public setting is. 	<ul> <li>state code. Many problematic issues that have come out of the legalization once it's a constitutional amendment it's difficult to correct statutorily. State leaders and voters need to consider these details and what the repercussions could be to our state.</li> <li>Businesses in Denver are in need of employees because so many people are using marijuana 20% of people within the workforce are failing drug tests or showing up to work impaired. These businesses now can't just fire an employee if there is THC found in them, they must prove that the individual is impaired. There are now cannabis treatment centers.</li> <li>You don't get a prescription for marijuana; you get referred to use marijuana.</li> <li>"Bud Tender" is assigned to each individual who goes into dispensaries. These "Bud Tenders" follow the shopper throughout the store to help lower theft issues.</li> <li>Many different options for concealing and using marijuana are for sale in stores.</li> <li>30% tax on marijuana in dispensaries.</li> <li>Bottles of cannabis elixirs are also being sold; liquid forms of cannabis for sale in CO.</li> <li>Extracts and oils are also readily available for dabbing and Vapes; very high THC concentration.</li> <li>Elisha Figueroa: We may be seeing some kind of bill during this next legislative session; either CBD or medical marijuana bill. Proponents of this have created a film called "Hope Vetoed" coming out next month which they will use to support their pursuit of legalizing CBD. There are over 20 FDA approved studies being done across the country using pharmaceutically produced CBD. They are measuring the effectiveness of CBD to treat medical ailments and conditions. Within the next year the Federal Government will be passing the legalization of medical CBD oil usage eliminating the need for any medical marijuana bill to be passed in Idaho.</li> </ul>
